#### 7. <u>Inter-Municipal Cooperative for Bidding Transportation Services for Summer 2013 and</u> <u>2013 – 2014 School Year</u>

7.1 WHEREAS, a number of public school districts in Nassau County wish to jointly solicit proposals, together with the Nassau Board of Cooperative Educational Services ("BOCES") for pupil transportation services for the 2013-2014 school year and Summer 2013 (and any renewal period) in accordance with the applicable provisions of General Municipal Law;

**WHEREAS,** the public school districts and the BOCES have agreed to form a Cooperative (the "Cooperative") for this purpose;

**WHEREAS,** the Carle Place School District, is desirous of participating in the Cooperative for joint solicitation of proposals for pupil transportation services as authorized by General Municipal Law, Section 119-0 in accordance with the terms and

conditions of the Inter-Municipal Cooperative Transportation Agreement attached hereto; and,

**NOW THEREFORE BE IT RESOLVED,** that the Board of Education authorizes the School District to participate in the Cooperative.

**BE IT FURTHER RESOLVED**, that the Board of Education hereby approves the Inter-Municipal Cooperative Transportation Agreement attached hereto and authorizes the Board President to execute the Agreement on behalf of the Board of Education as per the attached.
